This breaks down as the Training for \$350.00 per month/per horse for 3 days of training Tuesday thru Saturday, grooming, and exercising which is provided by Peet Equestrian LLC., **And** Board for \$500.00 per month/per horse which includes use of stall and property, 9 flakes of grass hay per day, 4 bags of shavings per week, and cleaning of stall, which is provided by Peet Equestrian LLC.

Partial Training Fee of \$850.00 is due and payable to Peet Equestrian LLC. for each month that the Owner's horse is at Peet Equestrian LLC.. Bills will be sent to Owner via email, within a timely manner with breakdown of fees for each month, prior to fee due date. Owner agrees to pay a \$25.00 late fee if fees are not received within 1 month of receiving the bill, and \$25.00 per each month after initial month due. Owner agrees to pay a \$25.00 per check fee, for checks returned for non-sufficient funds. All fees are subject to change by Peet Equestrian LLC. upon thirty (30) days written notice to Owner.

Should the horse require additional shavings above the 4 bags per week, extra bags of shavings can be used at owners expense, and these fees will be added in addition to the Basic Training fee listed above. O Initial: _____

Grain is not included in Partial Training fee and will be supplied at Owner's expense. Lien for Delinquent Money

Peet Equestrian LLC. has the right of lien for any delinquent monies past (90) days, for the amount due for training, boarding, showing, lessons, and additional agreed upon services and shall have the right, without process of law, to retain said horse until the indebtedness is satisfactorily paid in full, or to sell said horse as compensation to Peet Equestrian LLC..

This is the last route we would want to take to. Please talk to us the moment you feel that money may become a problem.

Owner hereby grants Peet Equestrian LLC. a possessory lien against the Owner's horse for the value of any unpaid training/boarding/showing/lesson or other charges due to Peet Equestrian LLC. under this Training Contract Agreement and any of its Addendum Contracts.. Owner agrees that in the event that the specified training/ boarding/showing/lesson fees and charges are not fully paid within ninety (90) days after the same have become due and payable, in accordance with this agreement, Peet Equestrian LLC. shall be permitted to exercise lien rights, and, in connection with these rights, to sell Owner's horse at private or public sale. Owner shall reimburse Peet Equestrian LLC. for the costs of such sale, including consignment fees, listing fees, hauling, stabling, attorney's fees, and other charges.

Peet Equestrian LLC. shall give Owner at least fourteen (14) days prior notice of any such intention to sell the horse(s) by:
(1) mailing a letter to Owner's last-known address [by regular, first-class mail] containing such intentions to Owner; and
(2) making reasonable attempts to reach owner by telephone. In the event that the sale of Owner's horse does not secure a sufficient price to pay the costs of training/ boarding/showing/lesson fees and charges due to Peet Equestrian LLC., plus hauling and mileage, and other reasonable expenses and costs of the sale, Owner shall pay Peet Equestrian LLC. the difference.

Peet Equestrian LLC. Show Handling Contract (Training Contract Addendum)

SHOW FEES - Flat Rate Pricing, Per Horse: One Flat Price for multiple classes! This is the fee that Peet Equestrian LLC. charges for the work, time, equipment, staff etc that goes into attending horse shows.

- Single Day Shows: \$100 (requiring no layover/hotel costs, typically Dressage Shows)
- A and B Rated Shows: \$400
- Regional Championship Shows: \$800
- IALHA Nationals: \$1,500
- Working Equitation Nationals: \$1,500
- World Cup Nationals: \$1,500

Flat Rate Fee Covers:

- Presentation/Handling of horse in **all** pre-determined classes.
- Decorating: Carpentry, lumber, drapes, landscaping, lighting, set-up and tear-down, upkeep and cleaning.
- Horse care: Box fan, matching halter and lead rope, feeding horse 3 times/day and cleaning stall 2 times/day, Horse groomed show ready per each class.
- Horse exercising and warm ups.
- Tack: bridles, bits, reins, saddles, saddle pads, harness, show halters.
- Grooming and Supplies: Shampoo, conditioner, hoof polish, show pepi, etc.
- Coaching of amateur and/or youth clients, at show on their horse.

Flat Rate Fee Exceptions:

- Show Tack: Some show tack can be provided by Peet Equestrian LLC. for \$30.00 per horse per horse show, including saddles, show bridles, bits, reins, saddle pads, show halters, harness and carts/carriages. If unable to provide tack, or if horse requires special tack, client will be responsible to buy show tack for their horse, which will be client property and be returned with horse.
- Show Carts & Carriages: These items add a great deal of difficulty to travel with and therefore in some instances require special transport. In the event of special transport, the client/s using these items will be asked to help cover additional costs of transportation which varies on distances to be traveled. (Truck rental & gas)

Flat Rate Charges Do Not Cover: Costs charged by persons/associations/businesses that are not affiliated with Peet Equestrian LLC., and are to be expected in addition to the Peet Equestrian LLC. Show Fee, and are to be paid by the owner.

- Body Clipper Fee
- Staff and staff expenses: hotel and meals. (Show groom and Stall Cleaner)
- Show Fees & Class Entries*
- Stall Fees & Bedding
- Early Arrival/ Late Departure Fee (we typically arrive 1-2 days early depending on show)
- Additional Stall Fees (Groom, Tack, Feed, Dressing, & Lounge) Cost is split between **all** owners in attendance at the show.

BODY CLIPPER FEE:

All show horses receive a body clip prior to each show, given by professional clipper. This fee will be billed by Peet Equestrian LLC. prior to body clip. A body clip costs around \$150. **O Initial:** _____

This breaks down as follows; Training services are \$700.00 per horse, per month, and includes training, conditioning, and grooming services/supplies, and use of Peet Equestrian LLC. training equipment, & Board services for \$500.00 includes use of stall and property, 9 flakes of grass hay per day, 4 bags of shavings/week and stalls cleaned.

-Failure to pay Training Fee by the end of the month will result in a late fee of \$25 per month.

SHOW FEES - Flat Rate Pricing, Per Horse: One Flat Price for multiple classes!

The fees that Peet Equestrian LLC. charges for the work, time, equipment, etc that goes into attending horse shows.

- Single Day Shows: \$100 (requiring no layover/hotel costs, typically Dressage Shows)
- A and B Rated Shows: \$400 (multiple day shows)
- Regional Championship Shows:\$800
- IALHA Nationals \$1,500
- Working Equitation Nationals \$1,500
- World Cup \$1,500

Flat Rate Charges Cover:

- Presentation/Handling of horse in all pre-determined classes.
- Decorating: Carpentry, lumber, drapes, landscaping, lighting, set-up and tear-down, upkeep and cleaning.
