Classes to be Shown In: A horse may have 1 division for a halter class, and 1 division for a performance class, but can go in any Open, Amateur, or Youth class. More than this will only be possible if there is not another horse to fill the spot. Owner will be made aware of the availability as show time closes in.

Peet Equestrian Show Handling Contract (Addendum to *Training Contract*)

Peet Equestrian Show Fees - Flat Rate Show Pricing, Per Horse: One Flat Price for multiple classes!

This is the fee that Peet Equestrian charges for the work, time, equipment, etc. that goes into attending horse shows.

- Single Day Shows: \$200 (requiring no layover/hotel costs, typically Dressage Shows)
- A and B Rated Shows: \$400 (multiple day shows requiring travel)
- Regional Championship Shows: \$800
- National Championship Shows \$1,500

In addition to the Show Fees, all hotel costs associated with Peet Equestrian traveling to and from shows will be split and charged amongst all clients attending that show. (e.g.: 4 clients going, charges split 4 ways. 1 client going, 1 client pays charges.)

Flat Rate Charges Cover:

- Presentation/Handling of horse in all pre-determined classes and all exercising and warmups.
- Horse care: Box fan, matching halter and lead rope, feeding horse 3 times/day and cleaning stall 2 times/day, horse groomed show ready per each class.
- Show Tack: bridles, bits, reins, saddles, saddle pads, harness, carts, show halters.
- Grooming Supplies: Shampoo, conditioner, hoof polish, show-pepi, etc.
- Coaching of amateur and/or youth clients, at show on their horse.
- Decorating: Carpentry, lumber, drapes, landscaping, lighting, set-up and tear-down, upkeep and cleaning.

Flat Rate Fee Exceptions:

- Some show tack can be provided by Peet Equestrian. If unable to provide tack, or if horse requires special tack, client will be responsible to buy show tack for their horse, which will be client property and be returned with horse.
- Show Carts & Carriages: These items can be difficult to transport and, in some instances, require special transport. In the event of special transport, the client/s using these items will be asked to help cover additional costs of transportation. (Truck rental & gas)
- Owner with multiple horses at a show- A discount may be given.

Flat Rate Charges **Do Not Cover:**

These are costs charged by persons/associations/businesses that are not affiliated with Peet Equestrian. These costs are to be expected in addition to the Peet Equestrian Show Fee and are to be paid by the client(s).

- Staff hotel expenses. (Peet Equestrian, assistants, grooms and/or stall cleaners.)
- Event Show Fees, Class Entries, and Stabling Fees
- Early Arrival and Late Departure Fee (we typically arrive 1-2 days early depending on show)
- Any other out-of-pocket expenses incurred on behalf of the client or client's horse while at show. (Farrier, vet. etc.)
- Tack Stall Fees (Groom room, Tack room, Feed room, Dressing room, & Lounge) Cost is split between all clients in attendance at the show.
- Feed – Hay, Grain, and Supplements. (When we are unable to transport the feed due to limited space on trailer(s).)
- Transportation of horses to/from show and any Layover Charges.

Peet Equestrian Show Handling Contract (Addendum to *Training Contract*)

Show Entry Fees:

These are the fees charged by the association putting on the show. These costs include but are not limited to: Class entry fees, office fees, stall fees, early arrival/late departure fees, drug test fees, membership fees, and add/scratch fees. These charges are in addition to the *Peet Equestrian Show Fee*. *Please see our attached “*Examples of Show Charges at Various Shows*” form to get a general idea of what you will be charged at the different shows. * **Client Initial:** _____

Hauling/Transportation Fees:

Peet Equestrian is not a horse transportation company. We can arrange for a horse transportation company or private individual to haul the horses to/from the shows. The cost and payment will be determined by the transportation company or private individual and paid by Client. Cost varies based on number of horses and distance traveled. We will inform Client of costs as soon as possible. Client is welcome to make your own transportation arrangements if you would prefer. For distances that span several days, overnight layovers will most likely be necessary and the cost is the responsibility of the client. **Client Initial:** _____

Body Clipper Fee:

All show horses receive a body clip usually twice a year, given by professional clipper, or by Peet Equestrian if needed. This fee will be billed by Peet Equestrian prior to body clip. A body clip costs \$150. **Client Initial:** _____

Carriage/Cart Transportation Fees:

If the carriage/cart will be used to have Client’s horse shown in a driving class, the Client understands and agrees to help with transportation costs of the carriage/cart should special transportation be needed due to lack of space on trailer.

IMPORTANT:

All Peet Equestrian Show Fees, and the Hauling Fees **must be received prior to departure for each show**. Horse will not be put on trailer if fees are not received in time. Show Entries, Class Fees, Stall Charges, and Office Fees will be paid by Client's Credit Card or Check, **prior to departure for each show**. Any other fees incurred by Client/Client’s horse at the show will be billed by the show office to the Client.

Necessary Paperwork

USEF- United States Equestrian Federation and Safe Sport: www.usef.org

Membership: \$80 per year

This is required to compete at any USEF/IALHA sanctioned breed show. You will be charged a Non-Member fee per show per horse if you do not have a USEF Membership.

USEF Lifetime Horse Identification: \$300 This is optional, but it will enable your horse to compete for USEF Year End Awards. Your membership and your horse's information must be up to date at the start of the competition year in order for points to be counted towards the horse competing for HOTY awards.

USEF also requires all adult USEF competitors and/or owners to be Safe Sport Certified. You will find the required courses in your USEF member dashboard. For information about Safe Sport- www.usef.org/safe-sport/training-instructions

IALHA- International Andalusian and Lusitano Horse Association: www.ialha.org

Full Membership: \$150 per year. Associate Membership: \$50 per year. Youth Membership: \$35 per year.

This is required to compete at any breed show. You will be charged a Non-Member fee per show per horse if you do not have a current IALHA Membership.

Your horse must be registered with the IALHA to compete at any IALHA sanctioned breed show. The registration process can take quite some time to complete and needs to be finished as soon as possible. Your horse **cannot** compete at the National Show without completed registration papers.

USDF- United States Dressage Federation: www.usdf.org

Membership: Participating- \$90 per year. Youth- \$72 per year. 5-year Participating- \$360

This is required to compete at any USEF/USDF sanctioned dressage show. You will be charged a Non-Member fee per show per horse if you do not have a USDF Membership.

USDF Lifetime Horse Identification: \$95 This is optional, but it will enable your horse to compete for USDF All Breeds Year End Awards.

USAWE- USA Working Equitation: www.usawe.org

Adult Membership: \$45 per year. Youth Membership: \$FREE.

Horse Recording #: One-time fee, \$20

Required to compete at any USAWE sanctioned working equitation show.

ANCCE- Asociación Nacional de Criadores de Caballos de Pura Raza Española: www.uspre.com

Your horse must be registered with ANCCE to compete at any ANCCE or USPRE sanctioned horse shows. The registration process can take quite some time to complete and needs to be finished as soon as possible. You **cannot** compete a horse over 3-years-old at an ANCCE Show without completed ANCCE registration papers.

There are many other associations (e.g. Carriage Association of America), that one can be a member of depending on what discipline you wish to compete in. Please do your homework and become a member of any other additional associations not listed here, if needed.

* We **require** copies of the above-mentioned memberships and registrations to be on file with us, depending on which shows you are competing at. Please get these to us ASAP. * You can email them to Erica at ericalpeet78@gmail.com Thank You.

Examples of Show Charges at various shows that we attend

These charges are strictly close examples of what you can expect to be charged by the various shows that we are available to attend. This form is meant to help prepare you for the charges involved with showing your horse/s this year depending on which show/s you decide to attend. We do not guarantee these to be the exact charges that you will be charged by the shows. These are very close estimates based on last year's shows and are subject to change with the new year and the location of the show. The exact charges will be discussed with you once we have received the new year's show premiums, prior to the shows. These show charges are per each horse being shown.

Regional A/L Breed Championship Show:

Typically, a 3-day show
\$25 Per Regular Class Entry
\$50 Per Championship Entry
\$30 Office Fee
\$23 Drug Fee
\$30 Stall Fee Per Day

IALHA National Show:

Typically, a 5-6-day show
\$150 Per Championship Class Entry
\$50 Office Fee
\$23 Drug Fee
\$200 Stall Fee Per Show Dates
\$25 Photographer Fee
\$50 Late Fee

Working Equitation, A or B-Rated Show:

Typically, a 162-day show
\$200-\$300 Per Class Entry
\$25 per day Stall Fee

Working Equitation, Championship Show:

Typically, a 3-day show
\$300-\$400 Per Class Entry
\$50 per day Stall Fee

Dressage Show:

Typically, a 1-2-day show
\$45 Per Class Entry
\$40 Office Fee
\$23 Drug Fee
\$50 Stall Fee Per Day
